***** BUILDING BYLAW *****

The Municipal Building Bylaw requires that non-agricultural construction, demolition or removal shall require the submission of a Building Permit Application Form prior to commencing any construction. Permit application forms are available at the RM office. Upon completion of a permit application, submit to the RM office for review. Permits will not be issued until all applicable fees are paid.

MUNICIPAL MILL RATE

THE MUNICIPAL MILL RATE FOR 2016 IS SET AT 15.0.

SASKATCHEWAN ASSESSMENT MANAGEMENT AGENCY, SAMA, CONDUCTS A FULL REVALUATION OF ALL PROPERTIES IN THE PROVINCE EVERY FOUR YEARS TO COINCIDE WITH THE CHANGE TO A NEW BASE DATE. THE NEXT REVALUATION WILL BE IN 2017.

New Regulations and Schedule of Fees at Landfill Effective August 17, 2015

New regulations and schedule of fees came into effect on Monday, August 17, 2015 as the current landfill is going to be converted to a transfer station in the future in which the transformation is going to incur a significant expense.

The RM of Meeting Lake is a proud to be supporter of STARS. The open area in front of the RM shop building in the Organized Hamlet of Mayfair is designated as a landing site for STARS helicopter air ambulance to land in an emergency.

The RM of Meeting Lake does not cover the cost or application of dust control products. Residents interested in purchasing and applying approved dust control products may do so at their expense. Please contact the RM office of location where dust control products were applied so that the grader operator will refrain from grading that portion of road.

Controlled Burning

Always report your planned control burn. When burning grass, bush piles, stubble, etc. please be sure you are well-prepared and that you have fire guards in place. Call these burns into the Control Burn Centre at 1-866-404-4911.
